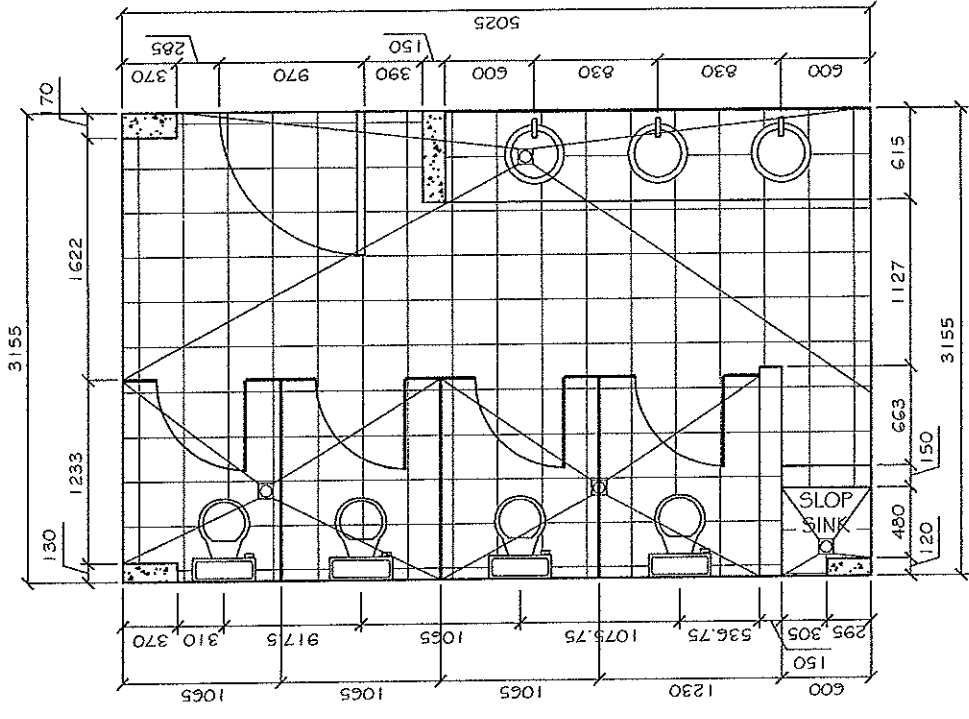

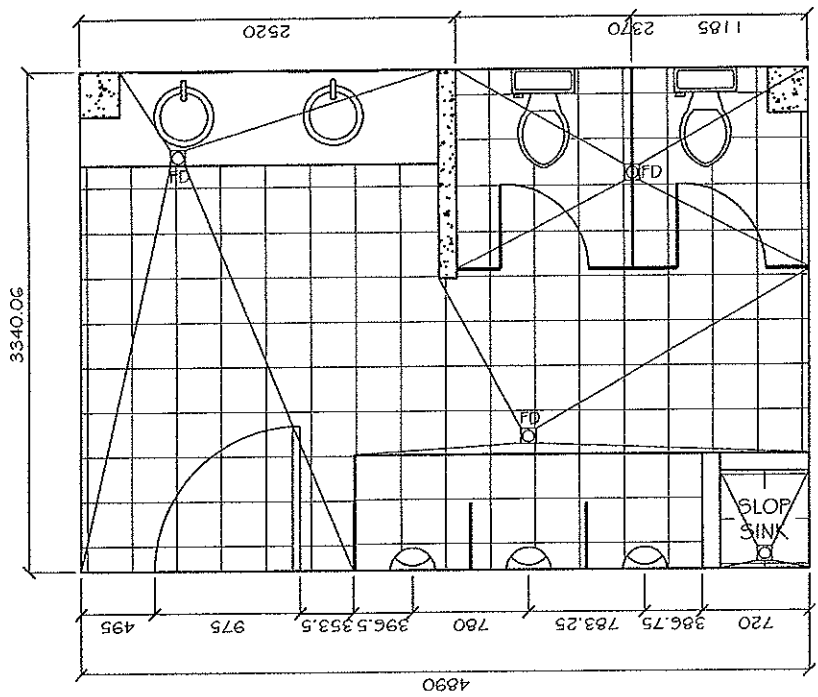


TYPICAL GROUND TO THIRD FLOOR
