SYSTEM OF RANKING OF DELIVERY UNITS AND INDIVIDUALS FOR PERFORMANCE-BASED BONUS FOR FISCAL YEAR 2017

The Inter-Agency Task Force on the Harmonization of National Government Performance Monitoring Information and Monitoring Systems (Administrative Order No. 25, s. 2011) issued Memorandum Circular No.2017-1 on March 9, 2017 which enumerates the guidelines on the grant of the Performance Based Bonus for Fiscal Year 2017.

To comply with the requirement for transparency of the ranking system to be used, the following procedures shall be observed by the University:

- 1. The University should meet the following as stipulated in Sections 4.0a, 40b and 4.0c of MC 2017-01 series of 2017:
 - 1.1 Satisfy 100% of the good governance conditions for 2017 set by the AO25 as provided in Section 5.0 of MC 2017-1;
 - 1.2 Meet at least 90% of FY2017 targets as reflected in the General Appropriation Act;
 - 1.3 Use the university Strategic Performance Management System (SPMS) approved by the Civil Service Commission in rating and ranking the Individual Performance and Commitment Review (PCR) of first and second level employees and officials of each delivery unit.
- 2. All qualified academic and administrative delivery units shall be ranked accordingly.
 - 2.1 For academic units which are composed of colleges, they shall be ranked based on their overall mean aggregate scores in terms of the four major final outputs: instruction, research, extension and production (see Annex A).
 - 2.2 Administrative delivery units will be ranked by the mean IPCR scores of the head and members of unit.
- 3. The eligibility of individual shall be guided accordingly by Section 7.0 to 7.18 of MC No. 2017-1.
